Penna. Construction Code Act.

#### 100.00 Construction Code:

- The Pennsylvania Construction Code Act requires the enactment of an appropriate ordinance by municipalities electing to administer and enforce the building code provisions of the Code.
- This Municipality hereby elects to administer and enforce the provisions of the Pennsylvania Construction Code Act, Act 45 of 1999, 35 P.S. §§7210.101-7210. 1103, as amended from time to time, and its regulations.
- The Uniform Construction Code, contained in 34 Pa. Code, Chapters 401-405, as amended from time to time, is hereby adopted and incorporated herein by reference as the municipal building code of this Municipality.

#### 200.000 Enforcement:

- Administration and enforcement of the Code within this Municipality shall be undertaken in any of the following ways as determined by the governing body of this Municipality from time to time by *Resolution*:
- By the designation of an employee of the Municipality to serve as the municipal code official to act on behalf of the Municipality;
- By the retention of one or more construction code officials or third-party agencies to act on behalf of the Municipality;
- By agreement with one or more other municipalities for the joint administration and enforcement of this Act through an inter-municipal agreement;
- By entering into a contract with another municipality for the administration and enforcement of this Act on behalf of this Municipality;
- By entering into an agreement with the Pennsylvania Department of Labor and Industry for plan review, inspections and enforcement of structures other than one-family or two-family dwelling units and utility and miscellaneous use structures.

### 300.00 A Board of Appeals:

- Council shall appoint by *Resolution*, and in conformity with the requirements of by the relevant provisions of the Code, as amended from time to time, members of the Board of Appeals.
- 300.20 If at any time enforcement and administration is undertaken jointly with one or more other municipalities, said Board of Appeals shall be established by joint action of the participating municipalities and in accordance with Laws of the Commonwealth of

Pennsylvania.

## **400.00** Existing Ordinances:

- All building code ordinances or portions of ordinances which were adopted by this Municipality on or before July 1, 1999, and which equal or exceed the requirements of the Code shall continue in full force and effect until such time as such provisions fail to equal or exceed the minimum requirements of the Code, as amended from time to time.
- All building code ordinances or portions of ordinances which are in effect as of the effective date of this ordinance and whose requirements are less than the minimum requirements of the Code are hereby amended to conform with the comparable provisions of the Code.
- 400.30 All relevant ordinances, regulations and policies of this Municipality not governed by the Code shall remain in full force and effect.

## 500.00 Penalties:

- Fees assessable by the Municipality for the administration and enforcement undertaken pursuant to this ordinance and the Code shall be established by the governing body by *Resolution* from time to time.
- Violations of this ordinance are subject to Fines are a Class C penalty as set by resolution of Council.

#### 600.00 Effective Date:

- This ordinance shall be effective five (5) days after the date of passage of this ordinance.

# **700.00 Repealer:**

700.10 If any section, subsection, sentence, or clause of this ordinance is held, for any reason, to be invalid, such decision or decisions shall not affect the validity of the remaining portions of this ordinance.
